PROGRAM REQUIREMENTS

- Products must be purchased from an authorized PBI-Gordon distributor between September 1, 2026, and December 4, 2026.
- Eligible orders must be placed by December 4, 2026, and invoiced by December 15, 2026.
- End-users may qualify for Tier I or Tier II rebate levels based on qualifying purchase volume. Volume thresholds vary by brand.
- Bonus rebates will be applied to qualifying rebate earnings.
- All transactions must be reported by distributors by January 31, 2027, through PBI-Gordon's data management partner.

PROGRAM QUALIFICATIONS:

- End-user registration must be completed by December 15, 2026.
- A minimum rebate of \$200 must be earned by the participating end-user to qualify.
- Rebates will be paid by July 31, 2027.

This program applies only to qualified end-user professionals in golf, lawn care, sports turf, schools, sod farms, and other turf management areas. Distributor sales to dealers do not qualify for this end-user rebate. Program calculations will be completed at the sole discretion of PBI-Gordon. Orders invoiced and shipped to end-users are subject to verification. If variances occur, payment reconciliation may be necessary. All reconciliation requests must be submitted with supporting documentation no later than September 30, 2027. Pricing and payment terms for listed products are determined by the distributor. PBI-Gordon reserves the right to audit, modify, or terminate this program at any time.

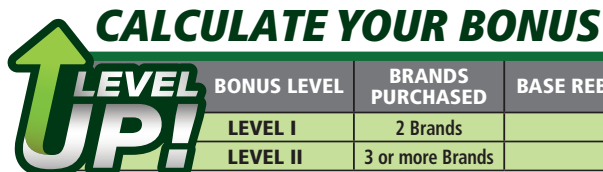
ENROLLMENT DETAILS

7. **Preferred Payment Method:** You may select and update your preferred payment method via the online form. Distributor credits remain available as a default payment option.
